



THIS IS A RELEASE OF ALL LIABILITY, A WAIVER OF RIGHTS AND AN AGREEMENT TO INDEMNIFY.

Please read this document carefully. If you sign it, you and your spouse will not be able to recover from the Town of Hudson or its personnel for any injury or damages you or your spouse may suffer from your participation in the participation in the Police "Ride Along" program - even if your injury or damages are the fault of Town of Hudson or its personnel. If you have questions about the meaning and effect of this document, contact your personal attorney.

In consideration of the undersigned Participant being allowed to participate in the Police "Ride Along" program of the Town of Hudson (hereinafter "Hudson") and in consideration of one dollar and other good and valuable consideration receipt of which is hereby acknowledged, the Participant and the Participant's spouse (hereinafter referred to collectively as the "Family") agree with Hudson as follows:

1. Release of Liability - Family hereby releases Hudson and its officials, employee and agents from any and all liability (or contribution to such liability) for physical or mental injury (including death), loss, damage, loss of consortium or other conjugal or marital rights, damage to loss, or loss of use of Family's property, and the consequential results of any and all the foregoing (whether or not resulting from the partial or sole negligence except gross negligence Hudson, its officials, employees and agents), any or all of which arise out of or from Participant's participation in the Police "Ride Along" program of Hudson.
2. Indemnification and Save and Hold Harmless - Family (individually and jointly and on behalf of their personal representatives, heirs and assigns) hereby agree to indemnify, save and hold harmless and defend Hudson and its officials, employees and agents from and against all claims and liability (or contribution to such liability) for physical or mental injury (including death), loss, damage, loss of consortium or other conjugal or marital rights to or of Participant, Participant's spouse, the children of either, and Family's personal representatives, heirs and assigns, and the consequential results of any of the foregoing (whether or not such claims or liability result from the partial or sole negligence except gross negligence of Hudson or its officials, employees and agents), which claims and liability arise out of or from Participant's participation in the Police "Ride Along" program of Hudson.
3. Waiver of Rights Under Statute - Family hereby waives any and all rights to recover or be indemnified for any amounts for which Hudson would be liable under any statute or law, (whether or not such right of recovery arises as the result of the partial or sole negligence except gross negligence of Hudson or its participation in the Police "Ride Along" program of Hudson.
4. Severability of Provisions - The provisions, paragraphs, subparagraphs, sentences, phrases and words of this document are severable, and the illegality or enforceability of any provision, paragraph, sub-paragraph, sentence, phase or word hereof shall not affect the legality or enforceability of any other provision, paragraph, sub-paragraph, sentence, phrase or word.

5. Compliance With Police Orders - Participant agrees to comply with all orders and rules of the Police personnel of Hudson with respect to the operation of the Police "Ride Along" program.

6. Potential Danger of Program - Participant and Participant's spouse have been advised and understand that Police operations encounter difficult and sometimes dangerous conditions which may put Participant's life and health in peril. Participant may not be able to avoid or escape serious injury or death.

Participant and Participant's spouse execute this document with full realization of the foregoing and of their free will.

7. Hudson's Reliance on Document - Family recognizes that Hudson would not allow Participant to participate in the Police "Ride Along" program without Family's acceptance of the provisions hereof. Hudson, thus, agreements contained in this document.

8. Definition of Incidents of Police "Ride Along" Program - For purposes of this document the police "Ride Along" Program includes, without implied limitation, observing, riding with and participating with Hudson Marshal or deputy Marshals in Police or Hudson operations or activities and approaching, entering, boarding, riding or being on, disembarking from leaving or being about any vehicle of said Hudson or its Marshal Office.
