# CHAPTER 5

## PARKS AND RECREATION

### ARTICLE 1. PARKS AND RECREATION IN GENERAL.

#### Sec. 5-1 Authority to Operate.<sup>1</sup>

The Town may establish, aid, maintain, and operate public parks, playgrounds, and recreation facilities and programs.

#### Sec. 5-2 Administration of Parks and Recreations Programs.<sup>2</sup>

The Town recognizes "Hardy Park" on Main Street as a public park in Hudson.

### ARTICLE 2. RULES AND REGULATIONS.

#### Sec. 5-11 Park Curfew.

All outdoor recreational and park lands shall have a curfew beginning at 9:00 p.m. and continuing until 7:00 a.m. on a year round basis. (Ord. No. 61, § 1, 8-28-78)

#### Sec. 5-12 Written Permission Required.

All use of the park without special permission of the Town Council of Hudson, Indiana, is limited to the hours between 7:00 a.m. and 9:00 p.m. Any individual within said park lands or outdoor recreational facilities between the hours of 9:00 p.m. to 7:00 a.m. without the written permission of the Town Council of Hudson, Indiana, shall be guilty of an ordinance violation. (Ord. No. 61, § 2, 8-28-78)
